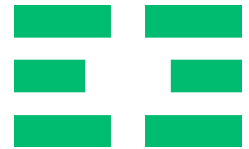

DESCRIPTION:

Acadia Pharmaceuticals does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk

Acadia has not used corporate funds to advance ideological causes, organizations, or policies (1)(2).

Uses corporate political contributions for ideological, non-business purposes. Lower Risk

Acadia does not operate a PAC at this time and has not lobbied for ideological causes (1)(2)(3).
