DESCRIPTION:

Check Point Software vets vendors for LGBTQ policies and does not provide viewpoint protections for its employees. However, the company has not publicly terminated business relationships based on views or beliefs. Check Point supports ESG within its business practices. However, it does not discriminate against religious organizations in its charitable giving and has not used corporate funds for ideological purposes. For these reasons, Check Point Software receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Medium Risk

Check Point has a written policy pledging to vet vendors for LGBTQ policies. Its Supply Chain Code of Conduct requires suppliers to include sexual orientation and gender identity in its nondiscrimination policy (1). However, the company has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Check Point does not discriminate against religious organizations in its charitable giving. The company focuses on funding organizations that support, "educational, environmental, health, welfare, social service, cultural and art causes" (1)(2)(3).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. High Risk

Check Point does not provide viewpoint protections for its employees (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. Medium Risk

Check Point supports ESG within its business practices. ESG "is of paramount importance" to the company. The company is

committed to carbon neutrality by 2040 (1). Otherwise, it has not supported ideological causes or policies (2)(3).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk

Check Point has not used corporate funds to advance ideological causes, organizations, or policies (1)(2).

Uses corporate political contributions for ideological, non-business purposes.
