### DESCRIPTION:

Bausch Health is Medium Risk. The company often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. Bausch Health occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

### Corporate Weaponization

**Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.** Medium Risk

*Bausch Health integrates ESG into its business practices. "As chairman and CEO, I am committed to continue integrating ESG standards and guidelines into our business and overall strategy" (1). The company has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (2).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.** Lower Risk

*Bausch Health does not appear to discriminate against charitable organizations based on views or beliefs. The company's charitable giving focus areas are "disease prevention, improving patient outcomes and lives, and education and community support related to our core businesses" (1)(2).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.** Medium Risk

*Bausch Health does not provide viewpoint protections for its employees (1).*
