DESCRIPTION:

Nucor, a steel producer, does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. The company has not used its reputation, corporate funds, or political contributions for ideological purposes. Nucor does not appear to discriminate against charitable organizations based on views or beliefs. For these reasons, Nucor receives a Lower Risk rating.

Nucor has not publicly terminated business relationships due to religious beliefs or political views (1).

Nucor does not discriminate against charitable organizations based on views or beliefs. The company focuses on funding organizations that support, "cancer efforts, veteran services, and education assistance" (1)($\frac{2}{2}$).

Nucor does not provide viewpoint protections for its employees (1).
