

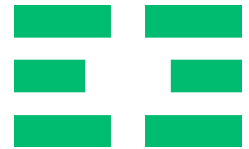

## DESCRIPTION:

World Fuel Services is a signatory of the Business Roundtable's 2019 Statement on the Purpose of Corporation, which promotes stakeholder capitalism. World Fuel Services does not actively engage in ideological battles or use its company funds to support partisan organizations or controversial policies. It does not discriminate based on religious beliefs or other viewpoints. For these reasons, World Fuel Services receives a "Lower Risk" rating.

### Corporate Weaponization

**Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.** Lower Risk

*World Fuel Services has not publicly terminated business relationships because of political or religious beliefs. Its discrimination policy does not explicitly extend to customers, suppliers, or vendors, but it has not discriminated based on viewpoints (1).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.** Lower Risk

*World Fuel Services does not offer an employee match program (1). There is no public evidence of discrimination regarding its charitable giving policies.*

**Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.** High Risk

*World Fuel Services does not protect its employees against viewpoint discrimination (1).*
