Allen Matkins does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

Allen Matkins has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

Charitable giving (including employee matching programs) policies or practices discriminate Lower Risk against charitable organizations based on views or religious beliefs.

Allen Matkins does not appear to discriminate against charitable organizations based on views or beliefs (<u>1</u>). The Allen Matkins Foundation was founded to "increase diversity within the legal profession and related industries by funding scholarships and awarding grants to worthy causes that advance the development of aspiring legal and business professionals of color" (<u>2</u>).

Allen Matkins does not provide viewpoint protections for its employees (1).

#### **Corporate Governance and Public Policy**

Allen Matkins supports DEI within its business practices, stating that its DEI "commitment is at the core of the Allen Matkins culture and purpose" ( $\underline{1}$ ). Otherwise, it has not supported ideological causes or policies ( $\underline{2}$ ).
