DESCRIPTION:

Vedder Price does not appear to discriminate against charitable organizations based on views or beliefs (1)(2).

Vedder Price is Mansfield Certified, indicating its support of DEI in its recruitment, hiring, promotions, and leadership composition (1)(2). Vedder Price does not provide viewpoint protections for its employees (3).

Vedder Price supports DEI within its business practices, stating that DEI "is one of our core values and is integral to the way we run our firm" (1).

Vedder Price donated to the Anti-Defamation League (1). Vedder Price sponsored the UK Lesbian and Gay Immigration Group (2). Otherwise, there are no publicly known cases of Vedder Price using corporate funds to advance ideological causes, organizations, or policies (3).

Uses corporate political actions and/or financial contributions for ideological, non-business Medium Risk purposes.
