### **DESCRIPTION:**

Authorize.Net, a payment gateway service provider, suddenly canceled a customer for legally selling firearms after years of doing business with the vendor. The company does not provide viewpoint protections for its employees. However, Authorize.net has not used its reputation or corporate funds for ideological purposes. For these reasons, Authorize.net receives a High Risk rating.

### **Corporate Weaponization**

Has denied service to customers, suppliers, or vendors due to their political views or religious High Risk beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Authorize.Net terminated its relationship with Hyatt Gun Shop in 2013 due to a then-recently instated company policy against selling firearms (<u>1</u>).

Authorize.net does not publish charitable giving guidelines.
