DESCRIPTION:

Namecheap, an IT service management company, does not publish a nondiscrimination policy. However, the company has not publicly terminated business relationships based on views or beliefs. Namecheap has donated to the Gay and Lesbian Alliance Against Defamation (GLAAD) in the past but has not used its reputation for ideological purposes. For these reasons, Namecheap receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

Namecheap has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Namecheap does not publish charitable giving guidelines.

In 2020, Namecheap pledged 3% of registration revenue (up to \$10,000) for .gay domain names to GLAAD [\(1\)](#). Otherwise, there are no publicly known cases of Namecheap using its corporate funds to advance ideological causes, organizations, or policies.

Uses corporate political contributions for ideological, non-business purposes.
