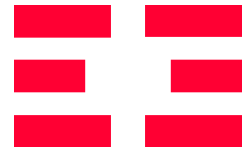

DESCRIPTION:

Michael Page International Inc. is High Risk. The company yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. The company embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach fails to safeguard free exercise, free speech, and free enterprise.

Corporate Weaponization

The company provides gender transition guidelines for its employees and a specific benefits guide with a comprehensive explanation of transgender services funded by the company (4)(5). Michael Page hosts diversity and awareness training for its employees (6). The company protects its employees against viewpoint discrimination (7).

Additionally, the company has potentially pledged philanthropic support of at least one organization or event that promotes sex and gender ideology.
