DESCRIPTION:

Winstead PC (Winstead) does not publish a nondiscrimination policy but has not publicly canceled business relationships based on views or beliefs. Winstead supports the Anti-Defamation League and the YWCA. Winstead is a part of the Law Firm Antiracism Alliance, committed to work on initiatives that fight "systemic racism". However, Winstead does not appear to discriminate against charitable organizations based on views or beliefs, and it has not used its reputation or PAC donations for ideological purposes. For these reasons, Winstead PC receives a Medium Risk rating.
