**DESCRIPTION:**

Harry's canceled its advertising relationships with the Daily Wire, claiming that one of the site's hosts made homophobic comments on his show. Harry's partnered with a transgender influencer to promote its razors and funds multiple LGBTQ organizations. However, the company protects its employees against viewpoint discrimination and does not discriminate against religious organizations in its charitable giving. For these reasons, Harry's receives a High Risk rating.

**Corporate Weaponization**

**Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.** High Risk

Harry's terminated its advertising relationship with the Daily Wire, accusing one of its hosts of homophobic and transphobic remarks ([1](#)).

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.** Lower Risk

Harry's does not discriminate against religious organizations in its charitable giving ([1](#)).
