**DESCRIPTION:**

The Association for Cooperative Operations Research and Development (ACORD) does not publish a nondiscrimination policy but has not publicly canceled business relationships based on views or beliefs. ACORD hosted a "DEIB in Action" workshop in 2023. However, ACORD does not appear to discriminate against charitable organizations based on views or beliefs and has not used its corporate funds for ideological purposes. For these reasons, ACORD receives a Lower Risk rating.
