DESCRIPTION:

AlixPartners has not terminated any business relationships due to religious or political beliefs, although it does vet suppliers according to LGBTQ policies. The company has supported the Equality Act but does not donate to ideological groups hostile to freedom of expression. For these reasons, AlixPartners receives a "Lower Risk" rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. **Medium Risk**

AlixPartners received a score of 100 on the Corporate Equality Index from the Human Rights Campaign (HRC) (1). Among other requirements, this means the company has pledged to vet vendors for LGBTQ policies. There is no record of AlixPartners publicly terminating a business relationship due to political or religious differences.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. **Lower Risk**

AlixPartners does not have a donation matching program. The AlixPartners Foundation operates on a limited and mission-focused basis and does not discriminate against religious organizations in its partnerships or grant making (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. **High Risk**

AlixPartners does not protect employees from political viewpoint discrimination (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. **Medium Risk**

AlixPartners is a member of the HRC's Business Coalition for the Equality Act (1).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk

In 2019, AlixPartners "partnered" with the HRC, although the company is not on the list of HRC Corporate Partners (1)(2).

Uses corporate political contributions for ideological, non-business purposes.
