DESCRIPTION:

WordPress, a web-hosting and site-building software, edited a user's blog posts for "deadnaming" transgender individuals, though the redaction of the name used was due to a privacy issue. However, the company has since updated its Terms of Service and reiterated its commitment to free speech. WordPress does not publish a nondiscrimination policy. However, the company has not used its reputation or corporate funds for ideological purposes. For these reasons, WordPress receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Medium Risk

In 2018, WordPress edited a user's blog that "published the former name" of a transgender individual and thus violated the company's Terms of Service, which included the dissemination of someone else's private details (including gender identity) as a removable offense (1). The redaction of this name was allegedly privacy-related, and the company has since updated its Terms of Service (2). The WordPress Terms of Service guidelines reiterate the company's commitment towards freedom of speech and political nonalignment.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

WordPress does not publish charitable giving guidelines.

High Risk

WordPress does not publish a nondiscrimination policy.
