#### **DESCRIPTION:**

ServiceNow scored a 100 on the 2023 Corporate Equality Index (CEI) from the Human Rights Campaign (HRC), a political stakeholder group. By complying with the HRCâ€<sup>™</sup>s controversial demands, ServiceNow, a cloud computing company, increases the risk of dividing employees, alienating customers and harming shareholders. The company covers transgender-related medical costs for its employees and their children and provides specific sexual orientation and gender identity-based benefits. It also uses sex and gender ideology criteria in employee recruitment, vendor selection, marketing, and philanthropic support. ServiceNow forces employees to undergo multiple ideological trainings and uses its reputation, corporate funds, and political influence to support controversial sex and gender ideologies, organizations, and legislation. ServiceNow does not provide viewpoint protections for its employees. The company has donated to the National Urban League and its CEO is a member of the Business Roundtable. ServiceNow opposed various state and local legislation intended to protect parental rights, girlsâ€<sup>™</sup> sports, bathroom facilities, and gendered spaces. For these reasons, ServiceNow receives a High Risk rating.

#### **Corporate Weaponization**

Has denied service to customers, suppliers, or vendors due to their political views or religious Medium Risk beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

ServiceNow received a score of 100 on the 2023 Corporate Equality Index (CEI) from the Human Rights Campaign (HRC), a political stakeholder group. The company recruits employees based on sexual identity issues. The company discriminates against vendors that do not promote divisive sex and gender policies, indicating it prioritizes sexual issues over merit (<u>1</u>)(<u>2</u>). ServiceNow has not publicly terminated business relationships due to religious beliefs or political views.

Charitable giving (including employee matching programs) policies or practices discriminate High Risk against charitable organizations based on views or religious beliefs.

ServiceNow's HRC CEI rating indicates the company will not donate to non-religious charities unless they embrace controversial sexual identity policies (<u>1)(2</u>).

# Employment policies fail to protect against discrimination based on political affiliation/views High Risk and/or religion.

ServiceNow's HRC 2023 CEI rating indicates the company forces employees to attend multiple, controversial trainings on gender identity, sexual orientation, transgender issues, and divisive racial ideology. The company provides gender transition guidelines for its employees and a specific benefits guide with a comprehensive explanation of transgender services funded by the company (1)(2).



### **Corporate Governance and Public Policy**

## Uses corporate reputation to support ideological causes and/or organizations hostile to freedom High Risk of expression.

ServiceNow's HRC 2023 CEI rating indicates the company agrees to allow a controversial stakeholder group focused on sexual identity issues to dictate marketing or advertising strategy (<u>1</u>)(<u>2</u>). By doing so, the company risks dividing employees, alienating customers and harming shareholders. ServiceNow signed a two-page ad in the New York Times expressing opposition to Georgia's 2021 election security laws (<u>3</u>). The company declared its support for various bills, including the John R. Lewis Voting Rights Advancement Act and the DREAM Act (<u>4</u>). ServiceNow's CEO Bill McDermott is a member of the Business Roundtable (<u>56</u>).

### Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom High Risk of expression.

ServiceNow's HRC 2023 CEI rating indicates the company covers transgender related costs for its employees and their children, including paid short-term leave, puberty blockers, cross-sex hormones, chest surgeries, genital surgeries, medical visits and lab monitoring, travel and lodging. Additionally, the company has pledged philanthropic support of at least one organization or event that promotes sex and gender ideology (<u>1</u>)(<u>2</u>). By allowing a political stakeholder group to dictate operations, the company increases health care costs and risks dividing employees, alienating customers and harming shareholders.<u>3</u>).

#### Uses corporate political contributions for ideological, non-business purposes.

High Risk

ServiceNow's HRC 2023 CEI rating indicates the company publicly advocated for controversial sex and gender ideology through local, state or federal legislation or initiatives (<u>1</u>)(<u>2</u>). By allowing a political stakeholder group to dictate operations, the company risks dividing employees, alienating customers and harming shareholders. ServiceNow does not operate a PAC at this time but has not lobbied for ideological purposes (<u>3</u>)(<u>4</u>)(<u>5</u>).
