Amegy Bank, a subsidiary of Zions Bancorporation, has not canceled business relationships due to religious or political beliefs and has not used its corporate reputation or funds to advance ideological causes. For these reasons, Amegy Bank receives a "Lower Risk" rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

There are no publicly known cases of Amegy Bank terminating business relationships due to religious or political beliefs.

Neither Amegy Bank nor its parent company Zions Bancorporation discriminates based on religious affiliation in their charitable giving programs (1)(2).

The Zions Bancorporation Code of Conduct, which was signed and adopted by all its subsidiaries (including Amegy), does not protect employees from political viewpoint discrimination (1).

Neither Amegy Bank nor Zions Bancorporation have used corporate reputation to support ideological groups (1)(2).

Neither Amegy Bank nor Zions Bancorporation has used corporate funds to support ideological groups hostile to freedom of expression (1)(2).

Uses corporate political contributions for ideological, non-business purposes. Lower Risk
