DESCRIPTION:

Logitech covers employees' abortion-related travel and publicly opposed the overturning of Roe v. Wade. The company uses its reputation and corporate dollars to support LGBTQ causes and organizations. Logitech has signed an HRC-led open letter protesting state-level LGBTQ-related legislation. However, Logitech has not terminated business relationships due to views or beliefs. For these reasons, Logitech receives a Medium Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

There are no known instances of Logitech terminating business relationships or an employee due to views or beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Logitech does not have a written rule discriminating against religious organizations in its charitable giving (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. High Risk

Logitech does not provide protections for its employees against viewpoint discrimination (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. High Risk

Logitech signed the HRC's Business Statement on Anti-LGBTQ State Legislation (1). Logitech also opposed the Supreme Court ruling overturning Roe v. Wade (2).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. High Risk

Logitech has pledged to reimburse its employees' abortion-related expenses, including out-of-state travel and lodging. This policy extends to dependents (1).

Uses corporate political contributions for ideological, non-business purposes.
