Overall, J&J Snack Foods does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

From its 2023 ESG Report: "We believe a thoughtful and accessible approach to environmental, social, and governance (ESG) is fundamental to our success" (1). Otherwise, there are no publicly known cases of the company using its reputation to advance ideological causes or policies (2).
