Lawrence Livermore National Security (LLNS) is Lower Risk. The company does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. LLNS has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

LLNS does not discriminate against charitable organizations based on views or beliefs. However, it will only give to religious organizations that provide non-sectarian services (1)(2).

LLNS has received the DEI Leadership Bronze award from the California Bar (1). The company formerly had a diversity plan. However, it was removed in February 2025 in accordance with executive order 14151 to reduce government waste (2). Otherwise, there are no publicly known cases of LLNS using its reputation to advance ideological causes or policies (3).
