DESCRIPTION:

Fastly, a cloud computing services provider, does not provide viewpoint protections for its employees. However, the company has not publicly terminated business relationships based on views or beliefs. Fastly was part of the Freedom for All Americans coalition and opposed various state and local legislation intended to protect parental rights, girls' sports, bathroom facilities, and gendered spaces. The company supports BLM but has not used its corporate funds for ideological purposes. Fastly does not discriminate against religious organizations in its charitable giving. The company is a member of the "Don't Ban Equality" business coalition. For these reasons, Fastly receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Lower Risk

Fastly has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

Lower Risk

Fastly does not discriminate against religious organizations in its charitable giving (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.

High Risk

Fastly does not provide viewpoint protections for its employees (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom High Risk of expression.

Fastly was part of the Freedom for All Americans coalition, which advocated for federal legislation that would overrule state laws designed to protect girls' sports and similar laws (1). The company opposed the Florida Parental Rights in Education Act, which would prohibit teaching gender identity and sexual orientation to kids in K-3rd grade (2). Fastly has endorsed the Black Lives Matter
