



# MART PetSmart

Locations: Arizona (HQ) Industries: Retailing



#### **DESCRIPTION:**

PetSmart scored a 100 on the Human Rights Campaign's (HRC) Corporate Equality Index (CEI). By complying with Human Rights Campaign's controversial demands, PetSmart increases the risk of dividing employees, alienating customers and harming shareholders. The company covers transgender-related medical costs for its employees and their children and provides specific sexual orientation and gender identity-based benefits. It also uses sex and gender ideology criteria in employee recruitment, vendor selection, marketing, and philanthropic support. PetSmart forces employees to undergo multiple ideological trainings and uses its reputation, corporate funds, and political influence to support controversial sex and gender ideologies, organizations, and legislation. PetSmart endorses the Equality Act and fails to provide protections against viewpoint discrimination. The company opposed various state and local legislation intended to protect parental rights, girls' sports, bathroom facilities, and gendered spaces. For these reasons, PetSmart receives a High Risk rating.

## **Corporate Weaponization**

Has denied service to customers, suppliers, or vendors due to their political views or religious Medium Risk beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

PetSmart received a score of 100recruits employees based on sexual identity issues. The company discriminates against vendors that do not promote divisive sex and gender policies, indicating it prioritizes sexual issues over merit (1)(2).

Charitable giving (including employee matching programs) policies or practices discriminate

High Risk against charitable organizations based on views or religious beliefs.

PetSmart's HRC CEI rating indicates the company will not donate to non-religious charities unless they embrace controversial sexual identity policies (1)(2).

Employment policies fail to protect against discrimination based on political affiliation/views High Risk and/or religion.

PetSmartindicates the company forces employees to attend multiple, controversial trainings on gender identity, sexual orientation, transgender issues, and divisive racial ideology. The company provides gender transition guidelines for its employees and specific benefits guide with a comprehensive explanation of transgender services funded by the company (1)(2). PetSmart3).



### **Corporate Governance and Public Policy**

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom High Risk of expression.

The company signed an open letter in support of the Equality Act (12). The company also created an LGBTQ Pride collection of dog supplies for pets to "show their Pride" (34). The companyindicates the company agrees to allow a controversial stakeholder group focused on sexual identity issues to dictate marketing or advertising strategy (5)(6). By doing so, the company risks dividing employees, alienating customers and harming shareholders.

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom High Risk of expression.

PetSmart donates to many LGBTQ advocacy organizations, including \$100,000 to the Gay, Lesbian and Straight Education Network, an LGBTQ organization (1HRC 2023 CEI rating indicates the company covers transgender related costs for its employees and their children, including paid short-term leave, puberty blockers, cross-sex hormones, chest surgeries, genital surgeries, medical visits and lab monitoring, travel and lodging. Additionally, the company has pledged philanthropic support of at least one organization or event that promotes sex and gender ideology (2)(3). By allowing a political stakeholder group to dictate operations, the company increases health care costs and risks dividing employees, alienating customers and harming shareholders (4).

#### Uses corporate political contributions for ideological, non-business purposes.

High Risk

PetSmartindicates the company publicly advocated for controversial sex and gender ideology through local, state or federal legislation or initiatives ( $\underline{1}$ )( $\underline{2}$ ). By allowing a political stakeholder group to dictate operations, the company risks dividing employees, alienating customers and harming shareholders. PetSmart has not used its PAC donations for ideological purposes and has not reported on its lobbying ( $\underline{3}$ )( $\underline{4}$ )( $\underline{5}$ ).
