



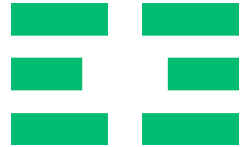

DESCRIPTION:

Axos Bank does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. Axos Bank has not used its reputation or corporate funds for ideological purposes. For these reasons, Axos Bank receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

Axos Bank has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs. Axos Bank shut down Alex Jones' company's bank account "without notice or warning". However, Axos claims that this action was due to unauthorized transactions and that the company did not respond after Axos reached out. Therefore, it is not clear whether Axos Bank's actions had anything to do with Alex Jones' viewpoints, but the bank did agree to reopen the account after 30 days [\(1\)](#).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Axos Bank makes incidental donations to San Diego-based relief efforts and funds, with no specific rule prohibiting collaboration with faith-based organizations [\(1\)](#)[\(2\)](#). Axos Bank does not discriminate against charitable organizations based on views or beliefs [\(3\)](#).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. High Risk
