Thrive Market released a statement in support of BLM in its Impact Report (<u>1</u>). It has also posted blog posts on its website advocating for LGBT causes (<u>2</u>).

The Thrive Market co-founders pledged to donate 50,000 to the BLM fund. Thrive Market also started an employee matching donation program where it matched employees' donations 2 to 1 to BLM (<u>1</u>).

Uses corporate political contributions for ideological, non-business purposes.
