## **DESCRIPTION:**

AliExpress does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Overall, AliExpress does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

## **Corporate Weaponization**

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Medium Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

While AliExpress has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs. However, it should be noted that company founder Jack Ma was forced out of his position in the Chinese Communist Party after criticizing the government's regulators in 2020 (1).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

AliExpress' charitable giving program, the Alibaba Poverty Relief Fund, is focused on alleviating poverty in China. The company does not appear to discriminate against charitable organizations based on views or beliefs (1).

Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.
