DESCRIPTION:

Alamo Group Inc. is Lower Risk. The company does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Overall, the company does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

Alamo Group appears to prioritize diversity over merit in its recruitment. From its Sustainability Report: "Alamo Group's outreach efforts have yielded an increase in diversity in most job categories. These actions include ... pressing search firms to source more diverse candidates, including passive diversity candidates who are not actively seeking new opportunities to attract them to our company" (1). The company is an affirmative action employer, "Alamo Group is proud to be an Equal Employment Opportunity, Affirmative Action employer" (2). The company does not provide viewpoint protections for its employees (3).

Corporate Governance and Public Policy

Uses corporate reputation to support causes, organizations, or policies hostile to freedom of expression. **High Risk**

Alamo Group supports DEI within its business practices. From its Investor Presentation: "Diversity is extremely important to Alamo Group's success. We strive to have our workforce closely reflect local demographics in the communities where we operate. Our culture is family friendly and welcoming to everyone" (1). The company supports ESG within its business practices. From its Sustainability page: "We take our ESG responsibilities and performance very seriously. We continue to learn more every day about what works well within our company, what contributes positively but needs further improvement, and what aspects of our business we need to rethink completely to achieve the ESG targets we have set for ourselves" (2).
