### DESCRIPTION:

Acciona is Medium Risk. The company often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. The company occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

### Corporate Weaponization

**Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. High Risk**

*Acciona integrates ESG into its business practices. "In 2024, ACCIONA continued promoting its Decarbonisation Strategic Plan and ESG challenges, reviewing the Sustainable Procurement Guide, which integrates sustainability from various perspectives" (1). The company will not conduct business with suppliers who do not maintain its outlined ESG standards and labels noncompliant suppliers as "No-Go's" (2).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk**

*Acciona does not discriminate against charitable organizations based on views or beliefs. The company's charitable giving focus areas are "Energy, water and sanitation for communities most in need" (1)(2).*

*Acciona protects its employees against viewpoint discrimination (1).*
