#### **DESCRIPTION:**

Hobby Lobby, a retail company, does not publish a nondiscrimination policy. However, the company has not publicly terminated business relationships based on views or beliefs. The company's CEO David Green previously spoke out against Obamacare but has not used corporate funds to advance ideological purposes. The company does not discriminate against charitable organizations based on views or beliefs. For these reasons, Hobby Lobby receives a Lower Risk rating.
