

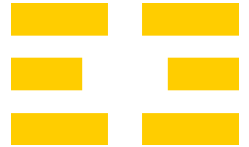

DESCRIPTION:

Alliant Insurance Services is Medium Risk. The company often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. The company occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

Alliant Insurance Services has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Alliant Insurance Services does not appear to discriminate against charitable organizations based on views or beliefs. The company's charitable giving focus areas are women and minority-owned businesses, Support people with disabilities, and Provide vital services for victims of abuse (1).

Alliant Insurance Services does not provide viewpoint protections for its employees (1)(2).

Corporate Governance and Public Policy

Alliant Insurance Services's Executive Chairman, Thomas W. Corbett, signed the CEO Action for Diversity & Inclusion pledge, which includes a commitment to promote DEI through bias education training in the workplace, strategize on DEI programs/initiatives with

other signatories, and engage boards of directors when developing and evaluating DEI strategies (1)(2). The company supports DEI within its business practices, hosting a DEI Committee and Officer (3)(4).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. High Risk

Alliant Insurance Service's is a Brass level sponsor of Out & Equal (1). The company is a corporate partner of the National LGBT Chamber of Commerce (2). Otherwise, there are no publicly known cases of the company using corporate funds to advance ideological causes, organizations, or policies (3).
