ADC Therapeutics SA (ADCT) is Lower Risk. The company does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Overall, the company does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

ADCT has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

ADCT does not discriminate against charitable organizations based on views or beliefs. The company's charitable giving focus areas are "organizations engaged in a healthcare-related charitable purpose aligned with ADC Therapeutics' mission and vision" (1).

ADCT appears to prioritize diversity over merit in its leadership composition. From its Corporate Governance Guidelines: Its Nomination and Corporate Governance committee will "periodically review the composition of the Board in light of the current challenges and needs of the Board and the Company, and determine whether it may be appropriate to add or remove individuals after considering issues of judgment, diversity, age, skills, background and experience" (1). The company does not provide viewpoint protections for its employees (2).

ADCT supports ESG within its business practices. From its ADC Therapeutics Press Release: The company has "pledg[ed] to continue ESG efforts as the company evolves" (1). The company supports DEI within its business practices. From its 2023 ESG Report: "We recognize diversity and inclusion is of paramount importance to employees, and society, and we constantly adjust our standards to set an ever higher bar for ourselves" (2).
