Medium Risk

### DESCRIPTION:

2Seventy Bio, Inc. is Medium Risk. The company often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. The company occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

### Corporate Weaponization

**Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.** **Medium Risk**

*2Seventy Bio integrates ESG into its business practices. From its Standards of Business Conduct and Ethics for Third Parties: "Account for and disclose the environmental footprint in operations. Take measures to reduce Greenhouse Gas Emissions, both from direct sources (Scope 1 & 2) and indirect sources (Scope 3)" (1). However, the company has not canceled customers, suppliers, or vendors based on political views or religious beliefs (2).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.** **Lower Risk**

*2Seventy Bio does not discriminate against charitable organizations based on views or beliefs (1)(2).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.** **High Risk**

*2Seventy Bio appears to prioritize diversity over merit in its supply chain. From its BMS ESG Report 2023: "We believe in the positive economic impact of engaging diverse suppliers" (1). The company does not provide viewpoint protections for its employees (2).*

### Corporate Governance and Public Policy

**Uses corporate reputation to support causes, organizations, or policies hostile to freedom of expression.** **Medium Risk**

2Seventy Bio supports DEI within its business practices. From its About Us page: "At 2seventy bio, we believe that it's about time that Diversity, Equity, Inclusion and Belonging become more than words. It is the core practice we are driven by in all we create" (1). Otherwise, there are no publicly known cases of the company using its reputation to advance ideological causes or policies (2).
