DESCRIPTION:

Mimecast, a cloud-based data security software, does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. Mimecast has hosted employee seminars on DEI topics such as unconscious bias. However, the company has not used corporate funds for ideological purposes. Mimecast does not appear to discriminate against charitable organizations based on views or beliefs. For these reasons, Mimecast receives a Lower Risk rating.
