DESCRIPTION:

Everence, a faith-based financial planning company, has not terminated pre-existing agreements due to religious or political beliefs. However, it will not create new business relationships with businesses opposed to its Christian company values. It has not used its reputation or corporate dollars to support ideological causes. For these reasons, Everence receives a "Lower Risk" rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

Everence will not invest in the gambling, tobacco, alcohol, or private military contracting industries [\(1\)](#). However, this policy is due to the incompatibility of those industries with Christian precepts rather than ESG requirements. Furthermore, Everence has not terminated preexisting contracts due to this policy.
