## **DESCRIPTION:**

Beacon Health Options vets vendors according to LGBTQ policies and does not provide its employees with protections against viewpoint discrimination, but has not publicly terminated business relationships based on views or beliefs. The company covers the cost of "medically necessary transition-related care― for its employees and their children. However, it does not discriminate against charitable organizations based on views or beliefs and has not used its corporate dollars for ideological purposes. For these reasons, Beacon Health Options receives a "Lower Risk" rating.

## **Corporate Weaponization**

Has denied service to customers, suppliers, or vendors due to their political views or religious M beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Medium Risk

Elevance Health (formerly Anthem), the parent company of Beacon Health Options, received a score of 100 on the Corporate Equality Index from the Human Rights Campaign (1). Among other requirements, this means Beacon Health Options vets suppliers according to LGBTQ policies.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

The Beacon Health Foundation does not discriminate against charitable organizations based on views or beliefs (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.

Beacon Health Options does not protect employees from viewpoint discrimination (1).
