

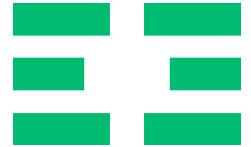

DESCRIPTION:

Ring, which specializes in security hardware for homes, has not publicly terminated business relationships due to religious or political beliefs. Ring was acquired by Amazon in 2018. Ring does not protect employees from viewpoint discrimination. It has not used its reputation or corporate dollars to support groups or agendas hostile to freedom of expression. For these reasons, Ring receives a "Lower Risk" rating.

Corporate Weaponization
