DESCRIPTION:

1Password often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. 1Password occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

1Password has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs.

Corporate Governance and Public Policy

Uses corporate reputation to support causes, organizations, or policies hostile to freedom of High Risk expression.

After Roe v. Wade was overturned, 1Password published a statement in support of abortion coverage and urged employees to vote on issues important to them (<u>1</u>). 1Password has committed to multiple acts of public advocacy for or engagement with the LGBTQ movement, including hosting Pride-themed Trivia and Pride-related workshops and financial webinars (<u>2</u>).



Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom High Risk of expression.

1Password published a statement that it would pay up to \$5,000 in travel expenses for employees seeking an abortion (1). The company also announced that it would donate \$25,000 to Planned Parenthood and \$25,000 to the United States of Women (2). 1Password encourages employees to use their Bonusly allowance for the Trevor Project and the ACLU (3). 1Password also donates to PFLAG Canada, an LGBTQ nonprofit, and the Trevor Project (4). 1Password donated \$85,214 to Black Lives Matter (5). 1Password donated \$25,000 to the ACLU and \$10,000 to The Trevor Project (6).
