## DESCRIPTION:

Sunflower Bank is a community bank headquartered in Denver. Sunflower Bank does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. Sunflower Bank has not used its reputation or corporate funds for ideological purposes. However, the bank's updated End User Agreement allows the bank broadly subjective powers in terminating payments. For these reasons, Sunflower Bank receives a Medium Risk rating.

## Corporate Weaponization

**Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.** **Medium Risk**

*Sunflower Bank has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs (1). However, the bank's End User Agreement states that the bank reserves the right to "block, cancel, and/or reverse" payments for "goods or services that include any language or images that are bigoted, hateful, racially offensive, vulgar, obscene, indecent or discourteous" (2).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.** **Lower Risk**

*Sunflower Bank does not discriminate against religious organizations in its charitable giving (1).*

**Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.** **High Risk**

*Sunflower Bank does not provide viewpoint protections for its employees (1).*

## Corporate Governance and Public Policy

**Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression.** **Lower Risk**

*has not supported ideological causes or policies (1).*

**Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk**
