Brink's is a security company headquartered in Richmond, VA. Though Brink's does not provide protections against viewpoint discrimination, the company has not terminated business relationships due to ideological differences. Brink's, however, will not match employee donations to religious organizations. For these reasons, Brink's earns a Lower Risk rating.
