DESCRIPTION:

Lincoln Savings Bank in Iowa has not publicly terminated any business relationships due to beliefs. Lincoln Savings Bank has not advanced ideological organizations hostile to freedom of expression, but the bank does donate to an LGBTQ organization. The Lincoln Savings Bank Foundation does not discriminate against religious organizations. For these reasons, Lincoln Savings Bank receives a Lower Risk rating.

Corporate Weaponization

Lincoln Savings Bank has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate Lower Risk against charitable organizations based on views or religious beliefs.

Lincoln Savings Bank has not published its charitable giving guidelines. However, its grant application does not mention any exclusion of religious organizations (<u>1</u>). The LSB Foundation states that it "donates thousands of dollars annually to charities, community groups, and other 501c(3) organizations" (<u>2</u>). Lincoln Love, the company's volunteer program, recommends serving at your church for volunteer hours (<u>3</u>). Religious organizations do not appear to be excluded.
