## **DESCRIPTION:**

TotalEnergies SE, does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. TotalEnergies does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

TotalEnergies has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

TotalEnergies does not discriminate against charitable organizations based on views or beliefs (1). TotalEnergies focuses its charitable giving on causes supporting children and young adults (2).
