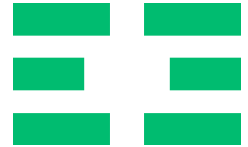

*Ipsen integrates ESG into its business practices. From its Business Partner Code of Conduct: "Business Partners shall have systems in place to quantify the amount of water used, energy consumed, waste generated and disposal mechanism, and greenhouse gases emitted by their operations" (1). The company has not publicly canceled customers, suppliers, or vendors based on views or beliefs (2).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk**
