



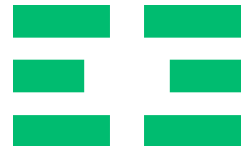

bioMerieux, a biotechnology company, vets international vendors for LGBTQ policies. It does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. bioMerieux has not used its reputation or corporate funds for ideological purposes. For these reasons, bioMerieux receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. **Medium Risk**

bioMerieux promotes divisive sex and gender policies. Its Global Supplier Code of Conduct requires international vendors to include sexual orientation and gender in their nondiscrimination policy (2). However, bioMerieux has not publicly fired customers, suppliers, or vendors based on views or beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. **Lower Risk**

bioMerieux does not discriminate against charitable organizations based on views or beliefs (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. **Medium Risk**

bioMerieux does not provide viewpoint protections for its employees (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. **Lower Risk**
