*In 2020, Jackson Hewitt canceled advertising agreements with Tucker Carlson's show on Fox News following comments Carlson made regarding the Black Lives Matter movement. Carlson alleged that BLM protests were "definitely not about black lives" and described them as "riots" [\(1\)](#)[\(2\)](#)[\(3\)](#).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk**

*Jackson Hewitt does not appear to discriminate against charitable organizations based on views or beliefs [\(1\)](#). The company's charitable giving focus areas are: "Higher education institutions, Health and human service organizations, Arts and cultural organizations, Environmental organizations, Civic and community organizations" [\(2\)](#).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature. Medium Risk**
