DESCRIPTION:

The Tupperware Brands Corporation provides protections against viewpoint discrimination, and the company has not publicly terminated business relationships due to views or beliefs. Tupperware has implemented ESG goals into its business practices, though the company has not funded ideological groups or PACs hostile to freedom of expression. For these reasons, Tupperware receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Lower Risk

There are no public instances of Tupperware terminating business relationships due to views or beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Tupperware has no written rules prohibiting charitable giving to religious organizations (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. Lower Risk

Tupperware provides protections against viewpoint discrimination (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. Medium Risk

Tupperware refers to ESG as an "integral" part of its business strategy, and the company has implemented practices such as climate commitments and signing the CEO Action for Diversity and Inclusion pledge (1)(2). However, Tupperware has not endorsed specific policies or legislation.

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk

Tupperware has not corporately funded ideological groups hostile to freedom of expression.

Uses corporate political contributions for ideological, non-business purposes. Lower Risk
