#### DESCRIPTION:

Autoliv has not terminated business relationships due to ideological differences or funded ideological groups hostile to freedom of expression. However, Autoliv does not provide viewpoint protections, and the company has integrated ESG practices, including some advocacy and unconscious bias trainings for employees. Autoliv vets all suppliers for sustainability requirements, and the company will not provide charitable donations to religious organizations. For these reasons, Autoliv receives a Medium Risk rating.

Sustainability criteria are included as a module in these pre-qualification audits and must be met before becoming an Autoliv supplier" (1).*
