#### **DESCRIPTION:**

Frontier Communications has not publicly fired customers, suppliers, or vendors based on views or beliefs. Although Frontier Communications endorses Pride Month, the company does not fund ideological groups or organizations. For these reasons, Frontier Communications receives a Lower Risk rating.
