## DESCRIPTION:

La Colombe Coffee Roasters does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. However, the company has integrated ESG into its business practices, including extensive legislative advocacy and donations to organizations such as ACLU and Planned Parenthood. La Colombe's CEO signed the CEOs for Gun Safety. The company provides a benefits package for employees which covers travel/lodging costs for an abortion. La Colombe is a member of the "Don't Ban Equality" business coalition. The company denounced various states' legislative efforts to protect election integrity and security. However, it has not discriminated against charitable organizations based on views or beliefs. For these reasons, La Colombe receives a Medium Risk rating.
