DESCRIPTION:

AGCO does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

AGCO Corporation has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs. However, AGCO Corporation integrates ESG into all of its business practices. The company has stated, "Embedding sustainability and ESG criteria in our purchasing decisions and in our management of suppliers and commodities is one of the strategic priorities of AGCO's 2025 Purchasing Strategy" (1). AGCO Corporation is establishing new sourcing principles for critical components, emphasizing improved sustainability and innovation rather than basing supplier selection largely on commercial considerations as in the past (2). AGCO Corporation has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (3).
