DESCRIPTION:

Earthlink does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. The company does have a subjective Acceptible Use Policy, though. Earthlink has not used its reputation or corporate funds for ideological purposes. For these reasons, Earthlink receives a Lower Risk rating.

Corporate Weaponization

Earthlink has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs. Earthlink's Acceptable Use Policy prohibits "Uploading, posting, publishing, or transmitting any material that (i) threatens, harasses, defames, or encourages bodily harm or destruction of property of an individual or a group, including on the basis of age, disability, ethnicity, national origin, gender or gender identity, race, religion, or sexual orientation, or (ii) espouses or promotes racism or bigotry" (<u>1</u>).
