

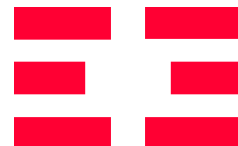

DESCRIPTION:

Limited Run Games is High Risk. The company yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. Limited Run Games embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach fails to safeguard free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. High Risk

Limited Run Games fired a community manager for following conservative accounts with her personal Twitter account. The allegations came after a transgender activist complained about the manager following "transphobic" accounts. The company responded by saying "LRG respects all personal opinions, however we remain committed to supporting an inclusive culture. Upon investigating a situation, an employee was terminated" (1)(2)(3).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Limited Run Games does not discriminate against charitable organizations based on views or beliefs (1).

Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature. Medium Risk
